

- Allocation of candidates to the Occupational Groups/Services, will be made keeping in view their merit position and suitability or unsuitability as determined by the Commission, preference of the candidates and domicile to qualify for Merit/Provincial/Regional/Women/ Minorities quotas as set out in the Rules for Competitive Examination (CSS), 2018.
- The Government, however, reserves the right to fill a smaller or a larger number of vacancies than those indicated in para 1 above.
