  - Educational profile proforma (sent to written qualified candidates via post)
  - Undertaking (sent to written qualified candidates via post)
  - Two recent passport size photographs
- In case of failure to bring the requisite documents, the candidate will not be allowed to appear in the Psychological Test. Furthermore, if a candidate remains absent in the Psychological Test, he/she will not be allowed to appear for Viva Voce.
- Five copies of Preference Form (sent to written qualified candidates via post) is to be furnished at the time of Viva Voce.
- Schedule of Viva Voce will be intimated later on.**
