After the test/ exam, on the basis of results, the candidates who are on higher merit positions in respective quota would be asked to furnish the attested copies of requisite documents.

- 4. Eligibility of the candidates in all respects shall be reckoned up to the closing date (i.e. 20.1.2020).

You are cautioned that requisitioning of the documents for determination of your eligibility shall not vest any right in you for the post until you are shortlisted on the basis of advertised merit and relevant Provincial / Regional quota as per policy of the Commission. In case you fail to submit these documents within stipulated period, your candidature for the captioned post shall stand rejected and no alibi or excuse shall be entertained subsequently.
