Captain (R) Zahid Saeed, Chairman, FPSC presented FPSC Annual Report-2020 to the President of Islamic Republic of Pakistan

The Chairman, FPSC briefed about the steps taken for empowerment of women/minorities and unfilled vacancies through Special CSS Examination to fill vacant vacancies of the respective regional quotas. CSS result updates (October-December 2021)

The Commission announced result of CSS Competitive Examination-2021 (written part) on 30-09-2021. Out of 39650, registered candidates, 17240 candidates appeared in the examination. FPSC notified 365 (2.11%) candidates qualified the written part. During October-December, 2021, the Commission conducted Viva Voce for written qualified candidates of CSS Competitive Examination-2021. Details are as under:

b. General Recruitment finalized cases: The Commission finalized **40** cases of general recruitment. Interviews of **3644** short-listed eligible candidates were conducted against **1367** posts and recommendations of **1135** candidates were made for various posts in BS-16 & above and **176** posts were reported unfilled to requisitioning Ministries/Divisions/ Departments due to non-availability of eligible and qualified candidates from specific provincial/ regional/ quotas or failure of candidates; **06 vacancies** reported withdrawn due to administrative issues of the Department. III. MCQ based Preliminary Test (MPT)

Federal Government/Cabinet approved a qualifying MCQ based Preliminary Test before CSS written exam w.e.f CE-2022 notified vide SRO No. 1516(1)/2021 dated 27.11.2021. Consequently advertisement was published on 28.11.2021 for online submission of applications from 28.11.2021 to 15.12.2021. The reservation of Halls has been completed. The Commission received 61,753 online applications for upcoming CSS-2022 and proceed for conducting MCQ Preliminary Test before CSS Written examination as per following details:
