Referring online applications and subsequent appearance in Written (Descriptive) Test for the subject post, following candidates are advised to furnish **BIO-DATA along with attested copies (with name stamp of attestation officer) of requisite documents as mentioned below, within 15 days of placement of this Notice on FPSC website, through Registered Post/Courier to determine their eligibility.** It may however, be understood that asking of requisite documents should not be inferred that the candidates have been shortlisted for interview and their eligibility in all respects in terms of advertised conditions shall be determined after scrutiny of their documents:

- Bio-data** form duly signed and filled-in completely. **(CANDIDATES ARE ADVISED TO DOWNLOAD THE GENERAL RECRUITMENT BIO-DATA-FORM FROM THE OFFICIAL WEBSITE OF FPSC i.e. <https://fpssc.gov.pk/downloads/forms>).**
- Two latest **Photographs** (Passport size).
- Valid Computerized National Identity Card (**CNIC**).
- Self **Domicile** Certificate (**SDC**).
- Secondary School Certificate (**SSC**) (showing date of birth)/Matric and Higher Secondary School Certificate (**HSSC**)/ Intermediate issued by Secretary, Board of Intermediate and Secondary Education. In case of 'O' Level and 'A' Level an equivalence certificate from Inter Board Committee of Chairmen (**IBCC**).
- (i) Ph.D. in Economics or equivalent qualification from a University recognized by the HEC. (ii) Eight (8) years post qualification experience in the field of Economic Research/ Macro-Economic Model-Building/ Policy making / Financial Management / implementation of Economic Policy in BS-17 and/or above or equivalent in a Government/ Semi-Government/ Public/ Private Sector Organization. OR (i) M.Phil. in Economics or equivalent qualification from a University recognized by the HEC. (ii) Ten (10) years post qualification experience in the field of Economic Research/ Macro-Economic Model-Building/ Policy making / Financial Management / implementation of Economic Policy in BS-17 and/or above or equivalent in a Government/ Semi-Government/ Public/ Private Sector Organization. OR (i) Second Class or Grade 'C' Master's degree in Economics or equivalent qualification from a University recognized by the HEC. (ii) Twelve (12) years post qualification experience in the field of Economic Research/ Macro-Economic Model-Building/ Policy making / Financial Management / implementation of Economic Policy in BS-17 and/or above or equivalent in a Government/ Semi-Government/ Public/ Private Sector Organization.**
- Degree(s) and Transcripts/ Result-Cards/ DMCs showing duration of study period, CGPA/ Grade/ Class with credit hours and **Result Declaration Date**, issued by Controller of Examination from a University recognized by Higher Education Commission (**HEC**) to determine eligibility.
- Wherever an equivalence of the required degree is to be claimed by a candidate, an equivalence certificate issued by HEC may be furnished to FPSC to authenticate the claim.
- Experience** Certificate (Post Qualification) with Job description and exact dates as per detailed Experience format (Annex-A available on FPSC's website).
- In case of **UNDERTAKING** provided by the candidate at the time of examination, Original **Treasury Receipt (TR)** being application fee deposited on or before the closing date of the advertisement in the Government treasury or in a branch of National Bank of Pakistan or in a State treasury, authorized to transact business on behalf of Government.
- In case of **Government Servant**, Original Departmental Permission Certificate (**DPC**) showing exact date of appointment and domicile on FPSC's prescribed format (available on FPSC's website) duly signed and stamped by Head of the Department/ Division/ Ministry (Official stamp must be affixed).
