INVITATION FOR PRE-QUALIFICATION THROUGH EPADS

Federal Public Service Commission intends to pre-qualify workshops / authorized agents of manufacturers having adequate technical soundness and requisite experience to cater for repair / maintenance work of the vehicles of Federal Public Service Commission on competitive bidding basis for FY 2024-25 in pursuance of Rule 15 and 16 of Public Procurement Rules 2004 and read with S.R.O. 296(I)/2023 27th February, 2023 title "E-Pak- Procurement Regulation 2023". Applications for pre-qualification are therefore invited through PPRA EPADS from the reputed workshops / authorized agents of manufacturers registered with sales tax and income tax departments and are on active tax payer list (ATL) of FBR.

2. Interested workshops / authorized agents of manufacturers who fulfill the following eligibility criteria may submit their applications for pre-qualification through PPRA EPADS (www.eprocure.gov.pk) on or before 25th September 2024 (Wednesday) 03:00 p.m. along with requisite documents as mentioned below:

ELIGIBILITY CRITERIA

The workshops / authorized agents of manufacturers must have: -

- i. Income and sales tax registration certificate.
- ii. Proof of active status on FBR's Active Tax-Payers List.
- iii. At least three years' experience of repair/maintenance of vehicles. Purchase/supply orders/performance certificates from clients (Public/Private organizations) for last 3 financial years must be provided.
- iv. List of clients during the last three years.
- v. Profile in term of machinery, equipment, technical service and available resources.
- vi. The workshops/ authorized agents of manufacturers to have setup in Islamabad/ Rawalpindi.
- vii. Copies of Income tax return for last 3 years.
- viii. Bid security amounting to Rs. 50,000/- (Rupees Fifty Thousand only) in favor of Secretary, Federal Public Service Commission, Islamabad must be submitted to Office of Director Logistics, FPSC, HQs, Aga Khan Road, F-5/1, Islamabad (Room#14).
- ix. Affidavit on stamp paper to be uploaded with bidding documents to the effect that workshop/company is not blacklisted.

TERMS AND CONDITIONS

- i. The workshop selected as pre-qualified will be bound to carry out the requisite work on immediate basis after vehicle is referred to it.
- ii. While submitting rates/ prices, the quotations must be inclusive of GST.
- iii. The workshops/authorized agents of manufacturers must provide undertaking on Rs.100/- judicial stamp paper, duly notarized, to complete the repair works as per the specifications mentioned in Work Order/EPADS Purchase Order. Any loss/damage done during such repair shall be compensated by the firm/workshop.

DISQUALIFICATION

Any workshop/firm under a declaration of ineligibility for corrupt fraudulent practices issued by any Federal/Provincial Government or any Public-Sector Organization will be declared "Disqualified" at first instance.

EVALUATION CRITERIA

- i. Evaluation criteria for pre-qualification of workshops/firms shall be as per **Annex-A**.
- ii. Workshops/firms attaining 70% score shall be eligible for pre-qualification.

INSTRUCTIONS TO APPLICANTS

Submission of Applications: -

- i. Applications for pre-qualification must be uploaded on EPADS be not later than 25th September, 2024 at latest by 03:00 p.m.
- ii. The applicants must respond to all questions and provide complete information as advised in this document.

 Any lapse to provide essential information may result into disqualification of the Applicant.
- iii. FPSC shall have the right to reject any or all bids and to accept the bid which in its judgment, best serves the interest of the Department/Government of Pakistan.
- iv. Applicants, and those subsequently prequalified or conditionally prequalified, shall be bound to inform the Client of any material change with information that might affect their qualification status. Firms shall be required to update key prequalification information at the time of authorization. Prior to award of contract, the lowest evaluated vendor will be required to confirm its continued qualified status in a post qualification review process.
