INSTRUCTIONS TO THE CANDIDATES FOR PSYCHOLOGICAL ASSESSMENT & VIVA VOCE

Psychological Assessment comprising one working day of all written qualified candidates will be carried as per Psychological Assessment programme. Viva Voce will follow thereafter. Schedule/programme can also be obtained from FPSC website.

2. All candidates are required to bring following with them on reporting for the Psychological Assessment:

- a. Two copies of recent passport size photographs, minimum two soft lead pencils (2B), a sharpener and an eraser.
- b. Duly filled/completed Educational Profile Proforma (attached herewith) for handing over to Testing Psychologist. Candidate shall not be allowed to appear for the Psychological Assessment without this proforma.
- c. Original certificates of Matriculation, Degrees, Self-Domicile, Computerized National Identity Card and Admission Certificate both at the time of Psychological Assessment and the Viva Voce. The Interview Board will refuse to interview a candidate failing to produce original certificates. These will be returned to the candidate on the spot, after inspection/verification.
- d. All supporting documents e.g. any co-curricular certificates, any prizes or positions won, membership certificates, or any other distinction received which may add to the credentials of the candidates and may be brought along with at the time of Psychological Assessment.

3. All candidates will also be medically examined by the Medical Board in accordance with Regulations for Physical Examination. The place, date and time of Medical Examination will be intimated as and when received from the Directorate of Central Health Establishment, Islamabad. Candidates who do not comply with the Instructions of the Medical Authorities and/or avoid taking Medical tests at the given time and place will be dealt with in terms of rule 13(7) and 16(4) of the CSS Rules. It must be noted that unless a candidate is declared medically fit, he/she will not be eligible for appointment as laid down in rule 13(1) of ibid rules.

4. Preferences/options for joining various groups are required to be given by all candidates as per attached proforma. These can be revised till date of Viva Voce for which revised preferences in the space provided in the form can be made. Same are required to be brought at the time of Viva Voce. Final Preference Form with overwriting, cutting, repetition will not be acceptable and no revision in the preferences will be accepted after the Viva Voce.

5. No candidate shall be considered for appointment to a Group/Service which is not opted for in the preferences. Any candidate declared "unsuitable" by the Commission for any particular service or occupational group will not be considered for the said service or group irrespective of his/her position in the order of merit. Candidate(s) can be offered a service or group irrespective of the fact whether opted for or not.

GUIDELINES FOR PSYCHOLOGICAL ASSESSMENT

1. The objective of Psychological Assessment is to estimate your ability and personality characteristics with special regard to your aptitude for the civil services. The procedure involved different exercise spread over one day only.
2. **No preparation is required for Psychological Assessment. Just be yourself, respond to the questions freely. Express your true feelings, opinions, judgments as they are.**
3. In the first phase you will be given written tests the purpose of which is to assess you and collect information about your interests, opinions and personal preferences etc.
4. In second phase you will participate in group activities. These include one group discussion and then an extempore speech of 2 minutes on general topic, about which you might have read, discussed with those around you and formed some opinion of your own. Subsequently you will get a problem usually related problems encountered in every day working. The part you play in the group tasks is expected to demonstrate whether you possess adequately the potential and qualities that are required in the members of the higher Civil Services of Pakistan.
5. The same day after the group session is over, you will meet Psychologist for a brief interview for providing any additional information that may be required to complete the record. Your awareness of surrounding will be checked.
6. Please bring supporting documents for your extra-curricular activities, job experience, publications etc. on the day of Psychological Assessment.
7. The Viva Voce will be conducted by the Commission according to the schedule provided to you separately.

GUIDANCE FOR CANDIDATES APPEARING BEFORE VIVA VOCE BOARD

Viva voce is an important part of evaluation and competitive selection. It helps in determining personal qualities like knowledge, ability, confidence, exposure, leadership qualities, initiative, decision making, fairness, judgment, critical thinking, innovativeness, communication skills and likewise.

2. Questions can be broad based and wide ranging. These can comprise of but not limited to the related subjects like Islam, ideology of Pakistan, challenges faced by the Muslim World, current national and international affairs, history, geography, geopolitics of South Asia, general knowledge, applied sciences, globalization and contemporary issues faced by Pakistan. Scenario based questions to judge problem solving abilities can also be asked.

3. Candidates are expected to give their original, frank forthright and independent yet structured views and opinions. Complex issues with inbuilt controversies at both national and international levels may also be discussed calling for clarity of mind. Well thought out, learned, ordered, discernable and unconstrained views are appreciable. No correct, proper, text books solution or answer is either expected or is considered plausible.

4. Logic, rationale and justifications bases on ground realities and facts presented in an orchestrated manner commands conviction and elicit favor in terms of score. Any opinion lacking reasoning is a matter lacking substance; it fails in thought provocation and therefore becomes futile.

5. Genuineness, balanced personality, honesty, decency, aptness, forthrightness, truthfulness, and sobriety are but a few traits of an established gentleman and civil servants this nation deserves. One of the highest aims in life is to “serve”, selflessly and unprecedentedly, for we all “Learn to Serve”. There is no other honor greater than serving one’s own motherland in whatever capacity possible.

6. It must be borne in mind that “Quality speaks for itself”. Therefore, no help can be gained from portraying behavior other than real.

7. Towards preparations, it suffices to say that, brilliant minds keep learning, while attaining qualifications and quality experiences, all adding to their intellect. Same must reflect in personality, conduct, articulated responses and overall performances.
