



NOTICE FOR SUBMISSION OF DOCUMENTS

Subject:- RECRUITMENT TO THE ELEVEN POSTS OF PROFESSOR (BS-20), PAKISTAN INSTITUTE OF MEDICAL SCIENCES (PIMS), ISLAMABAD, MINISTRY OF NATIONAL HEALTH SERVICES, REGULATIONS AND COORDINATION

Dear Candidate,

With reference to their online applications, the following candidates whose Names & Roll Numbers have been given below, are advised to furnish **BIO-DATA along with attested copies (with name stamp of attestation officer) of requisite documents as mentioned below, within 15 days of placement of this Notice on FPSC website, through Registered Post/Courier to determine their eligibility.** It may however, be understood that asking of requisite documents should not be inferred that the candidate have been shortlisted for interview and their eligibility in all respects in terms of advertised conditions shall be determined after scrutiny of their documents:

- a) **Bio-data** form duly signed and filled-in completely (to be downloaded from FPSC's website <https://fpssc.gov.pk/downloads/forms>)
- b) Two latest **Photographs** (Passport size).
- c) Valid Computerized National Identity Card (**CNIC**).
- d) Self **Domicile** Certificate (SDC).
- e) Secondary School Certificate (**SSC**)/Matric (showing date of birth) and Higher Secondary School Certificate (**HSSC**)/ Intermediate issued by Secretary, Board of Intermediate and Secondary Education. In case of 'O' level and 'A' level an equivalence certificate from Inter Board Committee of Chairmen (IBCC).
- f) **MINIMUM QUALIFICATION:** (i) MBBS or equivalent Medical qualification recognized by PMDC. OR M.Sc. of a recognized University in case of Basic Science in the relevant subject (for non-medical graduates). (ii) D.Sc., Ph.D., FCPS., M.D., M.S., M.Phil etc. in the respective subjects. FCPS/ M.D. with D.P.H. (for Public Health Institutions only). OR Equivalent qualification recognized by PMDC.
- g) **POST QUALIFICATION EXPERIENCE:** Three years teaching experience as an Associate Professor in the respective subject provided that total experience as Assistant Professor / Associate Professor is not less than eight years in a postgraduate institute. OR Nine years as Assistant Professor or four years teaching experience as Associate Professor in under graduate institute provided that total experience as Assistant Professor/ Associate Professor is not less than twelve years in under graduate institute.
- h) **RESEARCH:** Must have produced at least two research papers during three years as Associate Professor provided that total research papers as Assistant Professor/ Associate Professor are not less than five. OR At least three research papers during Associate Professorship provided that total research papers as Assistant Professor/ Associate Professor are not less than seven if experience is in under Graduate Medical college. **NOTE:** (a) For all Basic Science subjects a non-medical is eligible provided a medical graduate with requisite qualification is not available. (b) For appointment as a Professor, candidates possessing a D.Sc. / Ph.D. degree, the thesis or major subjects/ courses should be related to the subject in which they are appointed. (c) Candidates without a basic medical qualification are eligible for appointment as Professor provided they possess at least D.Sc. / Ph.D. degree and provided a medical graduate with the requisite qualification is not available
- i) Degree(s) and Transcripts/ Result-Cards/ DMCs showing duration of study period, credit hours with **proof** of CGPA/ Grade/ Class with credit hours and **Result Declaration Date**, issued by Controller of Examination from a University recognized by Higher Education Commission (**HEC**) to determine eligibility.
- j) Wherever an equivalence of the required degree is to be claimed by a candidate, an equivalence certificate issued by HEC/PEC/PMC/PNC may be furnished to FPSC to authenticate the claim.
- k) Valid **Registration** with HEC/PEC/PMC/PNC and such other institutions where applicable (if any).
- l) **Experience** Certificate (Post Qualification) with Job description and exact dates as per detailed Experience Format (Annex-A available on FPSC's website), **where applicable**.
- m) In case of **Government Servant**, Original Departmental Permission Certificate (**DPC**) showing exact date of appointment and domicile on FPSC's prescribed format (available on FPSC's website) duly signed and stamped by Head of the Department/ Division/ Ministry (Official stamp must be affixed).
- n) In case of **Non-Test** Case or **UNDERTAKING** provided by the candidate at the time of examination, Original **Treasure Receipt (TR)** being application fee deposited on or before the closing date of the advertisement in the Government treasury or in a branch of National Bank of Pakistan or in a State treasury, authorized to transact business on behalf of Government.
- o) Medical Certificate (if required/advertised) and Proof of Age Relaxation (if claimed).
