# Delegation of FPSC calls on the President of Pakistan

Details regarding representation of women and minorities in Government jobs to enhance their inclusion in the main stream of society were presented. According to the President House press release, FPSC had an important responsibility of recruiting civil servants to improve service delivery and promote good governance in the country. Therefore, he urged the need to make the recruitment process more efficient and transparent by adopting modern technology.

Accordingly, the 170<sup>th</sup> Meeting of the Commission was held on 12<sup>th</sup> & 13<sup>th</sup> August, 2024 at FPSC Headquarters, Islamabad. The Commission discussed various policy matters and important policy decisions as per agenda items were taken.

# Laying of FPSC Annual Reports in the Parliament

Annual Reports-2021 & 2022 of Federal Public Service Commission were laid in the National Assembly and the Senate of Pakistan as required under sub-section (1) of section (9) of the Federal Public Service Commission Ordinance, 1977, in National Assembly of Pakistan's session dated on 26<sup>th</sup> August, 2024 and the Senate of Pakistan 27<sup>th</sup> August, 2024 respectively.

# Activities Relating to CSS Competitive Examination during July-September 2024

#### Competitive Examination 2023:-

- Medical Examination of deferred candidates of CE-2023 was held at Lahore.
- Re-allocation of 06 candidates of CE-2023 were conveyed to the Establishment Division.
- Recommendations of 10 candidates belonging to Armed Forces Officers were made for induction into the Civil Service through CE-2023.

#### **Special CSS Competitive Examination 2023**

• Personal hearings were granted by the Commission to 194 rejected candidates of special CSS 2023.

#### **Competitive Examination 2024**

• Personal hearings were granted by the Commission to 96 rejected candidates of CSS 2024.

### Activities Relating to Final Passing Out Examinations during July-September 2024

The Commission announced result of Final Passing out Examination of 50<sup>th</sup> CTP including reexamination of earlier batches of the probationers belonging to 09 occupational groups/services during July-September, 2024.

#### **Other Competitive Examinations**

During July-September 2024, FPSC conducted 04 Competitive Examinations against which 1191 candidates were registered as per following detail:

# Activities relates to General Recruitment (July-September) 2024

- General Recruitment is an ongoing process which continues round the year. Therefore, 48 General Recruitment cases including cases of previous years were finalized by the Commission against 379 vacancies. 307 nominations were made whereas 70 vacancies remained unfilled due to non-availability of qualified candidates. 02 vacancies were withdrawn by the Ministry/Division/ Department due to different reasons.
- During the quarter July-September 2024, FPSC advertised 675 vacancies relating to BS-16 and above belonging to different Ministries, Divisions and Departments. Against such vacancies, 2024 58,639 applications were received online.
- Under general recruitment stream, Professional Screening Tests Phase-II/2024 was held involving 52 cases comprising 627 posts. For this test phase, 228,061 applications were received and 99,409 candidates appeared in the tests.
- 12 requisitions from Ministries/Divisions/Departments on Recruitment Rules were received and processed.
- 1231 candidates were called for interviews whereas 379 candidates were called for personal hearings.
