## JOIN SURVEY OF PAKISTAN, MINISTRY OF DEFENCE, RAWALPINDI

Case No. F.9-1/2020-P&PE. Competitive Examination-2020 for recruitment to 02 posts (*Punjab =01 & Sindh (R) = 01*) of **Assistant Director (BS-17)**, in the Survey of Pakistan will tentatively be held w.e.f.15.11.2020 simultaneously, at Islamabad, Lahore, Karachi, Peshawar and Quetta subject to sufficient number of candidates at the respective station. Both male & female candidates are eligible.

2. In terms of Rules Notified vide SRO 305(I)/85 dated 31.3.1985 and SRO 57(KE)/2014 dated 14.7.2014 (placed at FPSC Website [www.fpsc.gov.pk](http://www.fpsc.gov.pk)) following shall be the eligibility criteria for Competitive Examination-2018:-

### I. Eligibility Criteria:

- ii) **Educational Qualification:** 2<sup>nd</sup> Class Bachelor's Degree with Mathematics/ Geography/Physics/ Chemistry as one of the main subject from a recognized University **OR** 2<sup>nd</sup> Class Bachelor's Degree in Civil/Mechanical/Electrical Engineering from a recognized University.
- iii) **Physical Standards:**  
*Minimum Height: 5ft; Minimum Chest Measurements: 33"with a minimum expansion of 2 inches*
- iv) **Age Limits:** 22-32 years plus 05 years general relaxation in upper age limit as admissible in Initial Appointment to Civil Posts (Relaxation of Upper Age Limit) Rules, 1993. For details about age relaxations, see the Rules ibid available on FPSC Website.

### II. Written Examination (900 marks):

- i) *Subjects for the Competitive Examination shall comprise of compulsory papers of 700 marks and optional papers of 200 marks as given in Guidelines of the syllabus for Competitive Examination-2018 of said posts available on FPSC Website.*
- ii) *Each paper shall be of 100 marks and 03 hours duration.*
- iii) *The medium of the Examination shall be English. However, the question paper in Islamiyat may be answered in English or Urdu.*
- iv) *The standard of subjects shall be Bachelor's degree of a Pakistani university.*
- v) *The Examination shall be passed by a candidate as a whole and not in parts.*
- vi) *Optional subjects once chosen at the time of submission of online application shall not be allowed to change subsequently. Change of optional subjects in hard copy of online form shall also not be allowed.*

### III. Viva Voce: 300 Marks

IV). **Qualifying Marks:** *The qualifying marks for the written examination will be 50% in the aggregate and 40% in all compulsory including Mathematics and other optional subjects and 100 marks in the viva voce".*

V). **Cut of date to determine eligibility:** **08.09.2020 i.e. closing date**

3. **Exam Fee:** Exam Fee Rs.2200/- (non-refundable) is to be deposited in the National Bank of Pakistan under the Head of Account "C-02101-Organs of State, FPSC Exam Fee" Blank Treasury Challan (T.R.6) is available at FPSC website, which can be downloaded.

4. **PROCEDURE FOR SUBMISSION OF APPLICATION:** All aspirants must apply online through FPSC website [www.fpsc.gov.pk](http://www.fpsc.gov.pk) for the said Competitive Examination-2020 on or before 08.09.2020 followed by submission of hard copy of online form alongwith all documents, so as to reach the FPSC Headquarters, Islamabad within 10 days of the closing date i.e. upto 18.09.2020. No request for change of Optional Subjects and Centre is allowed.
